# Tom Sander Gill and family

Tom Sander Gill was named as the other friend in the Will of John Lister Clay reported in *Huddersfield Daily Examiner* Monday January 4 1965

He left .....£100 to the Vicar and churchwardens of the Parish Church of St. Matthew, Lightcliffe, upon trust to apply the income there from the upkeep of the graveyard and the graves of "my late friends the Rev. Savile Brinton Lewis Hall and Tom Sander Gill";

## **John Lister Clay and family**

Tom, his parents, four sisters and his maternal grandfather were all buried in St. Matthew's churchyard, Lightcliffe, although all of them were born in Cumberland.

Tom Sander Gill was born in Skirwith, Cumberland on 6<sup>th</sup> November 1883 to parents John Gill and his wife Ann née Brown. They had married in Ousby, Cumberland on 13<sup>th</sup> July 1872. John Gill's father, another John Gill was an agricultural labourer in Skirwith married to Martha.

Ann Brown was the daughter of William Brown and his wife Jemima Cook Sander who also married in Ousby, Cumberland on 1<sup>st</sup> June 1844. The origin of Tom's middle name is now known. Over the years maternal grandfather William Brown was a copper miner, a lead miner and a blacksmith in Cumberland.

On the 1881 census, before Tom Sander Gill was born, John and Annie Gill's family looked like this.

A sister Phyllis Mary Gill was born Q2 1886. Her birth was registered in the Penrith district as were those for all her five siblings: Sarah Martha Q4 1872, Elizabeth Ann Q1 1876, Isabella Q3 1877, John William Q3 1879 and Tom Sander Q4 1883.

Sarah Martha Gill was baptised in Ousby, Cumberland on 27<sup>th</sup> July 1873.

Then the Gill family moved to Lightcliffe probably to the Gomersall Buildings in what is now Ripley Street as there is a *National School Admission Registers & Log-Books 1870-1914* record dated 29<sup>th</sup> October 1888 for Tom Sander Gill, father John Gill, residence 'Gomersall'. The school was Lightcliffe Mixed Infants which Tom left aged 4 years and 11 months presumably on that date. Perhaps he then transferred to Lightcliffe Boys' School?

On 5<sup>th</sup> April 1891 the Gill family were recorded as being in Ripley Street. This may have been in the same property but with another name. Ripley Street was built by the stone mason Jeremiah Gomersall. The house at the end by Wakefield Road was known as Gomersall Building in 1891. It is possible that the whole row of terrace houses was called or at least referred to as Gomersall Buildings.

13-year-old Isabella Gill was not far away at Cliffe Hill mansion, Lightcliffe where she worked as a 'Kitchen Maid' for Benjamin Scarf and his family. He was a 53-year-old Stuff Merchant, Iron Master & Colliery Proprietor. When he died in 1893, he left over £140,000



The oldest and youngest Gill daughters were visiting their grandfather in Cumberland.

Just over a year later John Gill died on 25<sup>th</sup> June 1892. He was buried in plot K27 in Lightcliffe churchyard, owned by his wife Annie, on 27<sup>th</sup> June 1892



Annie Gill also owned plot K28 which was where her father, 82-year-old William Brown was buried on 1st October 1896.



Eldest daughter Sarah Martha Gill, of Gomersall Building, Lightcliffe, married John William Pulman on Boxing Day 1898 in Halifax. He was a weaver the son of James Pulman, a delver. Their daughter Ellen Pulman was born on 7<sup>th</sup> March 1899 and then baptised at St. Matthew's Church, Lightcliffe, on 7<sup>th</sup> May 1899. Her father was again a carpet weaver, and the family lived in Ripley Street.

In between this birth and the baptism her mother's sister, Isabella Gill, married Albert Booth on 22<sup>nd</sup> April 1899. Albert Booth was another weaver but from Brighouse. His ancestors and wider family have more Lightcliffe connection, but their full story will have to wait until later. Isabella's address was Ripley Street, Lightcliffe which was also the address on the baptism record for Edith Booth, born 8<sup>th</sup> July 1899 and baptised at St. Matthew's on 10<sup>th</sup> September 1899. Albert Booth and family then moved to Bradford Road before the 31<sup>st</sup> March 1901 as you can see from the 1901 census. It looks as if a number of the Gill family worked at the Bailiffe Bridge carpet factory owned by T. F. Firths & Sons.

Twins Tom and Ethel Pulman were born on the 11<sup>th</sup> May 1902 and baptised at St. Matthew's church on 10<sup>th</sup> August 1902. Their father was still a carpet weaver. The family's address was simply given as Lightcliffe but it was almost certainly in Ripley Street.

More Booth children arrived; Olive born 19<sup>th</sup> September 1901, Herbert born Q2 1904, Ethel born 13<sup>th</sup> December 1906. John William born 25<sup>th</sup> August 1908 and Amy born Q4 1910. They were not baptised at Lightcliffe but when 3-year-old Herbert died on 1<sup>st</sup> April 1908 he was buried in plot M20 of St. Matthew's churchyard three days later.

Their uncle's name appears in another *National School Admission Registers & Log-Books* 1870-1914 record. Tom Sander Gill of 26, Ripley Street, Lightcliffe, aged 19 years 9 months on the form, dated 1<sup>st</sup> October 1903, enrolled at the Technical College, Halifax. The form says that his parent's occupation was a 'Clerk' but from the 1901 census occupation for Tom this was almost certainly his occupation and not that of his deceased father.

During this period between the two censuses, Tom attended meetings of the St. Matthew's Young Men's Society at Lightcliffe. An account of the society's annual meeting in 1904 has Tom Gill as the secretary and John Lister Clay as the treasurer. There are many newspaper reports relating to this society, a couple of examples are shown below.

## LIGHTCLIFFE ST. MATTHEW'S YOUNG MEN'S SOCIETY

The annual general meeting was held on Monday night, the Rev. R. P. Whittingon presiding over a good attendance. The hon. Secretatry (Mr. T. S. Gill) read the report for the last session, and the hon. Treasurer (Mr. J. Norwood) presented the balance-sheet and report. The following officers were elected: President Rev. R. P. Whittington; vice-presidents, Rev. H. H. Green, Mr. J. Dixon, Mr. J. L. Clay, Mr. T. H. Norwood, Mr. E. H. Knowles, Mr. A. P. Knowles, and Mr. G. G. Haque. Mr. T. S. Gill was reelected hon-Secretary. Mr. J. Norwood hon. Treasurer, and the committee comprised Messrs. L. Lee, A. Thornton, C. Taylor, G. Pickles, T. E. Norwood and J. Blackburn. The reports showed that the society was in a flourishing condition, both as regards membership and finance.

Like his friend John Lister Clay, Tom Sander Gill was also a sidesman at St. Matthew's Church attending meetings and being involved with him in auditing the church accounts.

From 1910 to 1913 Tom Sander Gill appears on the Electoral List for Parliamentary County of West Riding of Yorkshire, Northern Part, Elland Division. As you can see, he was lodging with his mother at 26, Ripley Street which is where he was on 2<sup>nd</sup> April 1911.



It looks as if the two unmarried Gill sisters as well as their two brothers-inlaw worked at the carpet factory owned

by T. F. Firths & Sons,

In the spring of 1913, unmarried sisters Elizabeth Ann Gill and Phyllis Mary Gill died within a month of one another. Thirty-seven-year Elizabeth Ann died on 3rd March. She was buried with her father in Lightcliffe plot K27 on 5<sup>th</sup> March 1913. Her sister Phyllis Mary joined them on 3<sup>rd</sup> April after she died on 1<sup>st</sup> April 1913. She was aged 26 years. It is tempting to wonder whether their deaths were linked.





Their sister Isabella Booth née Gill had a baby boy, Harold Booth, on 11th April 1913. Oldest sister Sarah Martha Pulman née Gill had a daughter Mary Pulman on 10th October 1914.

Meanwhile their uncle, Tom Sander Gill, had joined Lightcliffe Golf Club.

A copy of the list of some trophy winners – kindly sent by Ian Philp – confirms TS GILL's 1914 win.

No trophies were played for during the next four years due to WW1.

The Brighouse trophy win was referred to at the 1914 annual general meeting of Lightcliffe Golf Club with some additional information about Tom Sander Gill.

The Club cup had been won by Mr. G. S. Haslam, the Brighouse trophy by Mr. T. S. Gill, and the captain's prize by Mr. W. Brearley.

Mr. R. Sugden next proposed a vote of thanks to Mr. T. S. Gill, the late secretary, for his service, and expressed great regret at his illness, and the hope that he would soon be restored to his usual health.

Mr. B. Clay seconded, and the motion was carried enthusiastically.

Mr. B. Clay was almost certainly Arthur Bryan Clay, the son of Arthur Hick Clay of Lyndhurst, Lightcliffe, and so nephew of John Lister Clay.

Then there was this announcement in the *Halifax Daily Guardian* on 18th December 1915.

### **DEATHS**

GILL – On December 15<sup>th</sup>, Tom Sander Gill, of Lightcliffe, aged 32 years. Funeral at Lightcliffe Old Church, on Saturday, December 18<sup>th</sup> at 3.30 p.m.

As Tom Sander Gill's death certificate shows he died in the Penrith district at Skirwith where he was born. His death was registered on 17<sup>th</sup> December 1915 by a relative, his half cousin Mrs Mary Atkinson of Croft House where he died.

The cause of death 'Phthisis Pulmonalis' is a term that means a wasting or consuming condition of the lungs, especially caused by tuberculosis. It is also called consumption, phthisis, or the great white plague. This must have been the illness Tom Sander Gill was suffering from when he resigned as secretary of Lightcliffe Golf Club.

Then as his condition deteriorated, perhaps he saw this advert in the *Bradford Daily Telegraph* on 1<sup>st</sup> July 1915

BOARD-LODGINGS (comfortable) Vacant: piano, pony and trap near to fells and lake district.

MRS ATKINSON, Croft House, Skirwith, Langwathby, Cumberland

Or because Mary Atkinson was a relative, perhaps he was already at Croft House hoping that some pony and trap rides in the Lake District fresh air would help his lung condition. Tom Sander Gill's body was brought back to Lightcliffe for burial in St. Matthew's churchyard on 18<sup>th</sup> December 1915. He was buried with his maternal grandfather in plot K28. It is easy to see how the grave code in the parish burial record below has been mis-transcribed as R28. No obituary or account of the funeral has been found.

She was buried with her little brother in plot M20 on 31<sup>st</sup> January 1916. The parish record has an interesting note entered on the right hand side which says:-

In consequence of some confusion, M20 and M19 are merged into one grave and reckoned as M20 and the owner of M19 has N18 – the space immediately on north side of the grave of William, Albert and Anne Booth, reserved for him.

A few months later her mother Isabella Booth died on 30<sup>th</sup> April 1916. She was buried in Lightcliffe churchyard in the merged plot, M20, on 3<sup>rd</sup> May 1916 with her young son and daughter. In the space of three years widow Ann Gill had lost three daughters, a son and a granddaughter; not forgetting the Booth grandson who died in 1908.

But within a year there would be more deaths. Eldest daughter Sarah Martha Pulman née Gill died on 15<sup>th</sup> May 1917. She too was buried in St. Matthew's churchyard on 18<sup>th</sup> May 1917 in plot L81. And then just a few days late on 1<sup>st</sup> June 1917 Ann Gill died. Her death was registered in the Huddersfield district as by then she was probably living with her only surviving son John William Gill and his family. On the 1911 census he was a gardener in South Crosland, Huddersfield.



Sixty-seven-year-old Ann Gill was also brought back to Lightcliffe for burial on 2<sup>nd</sup> June 1917 in plot K28 with her father, William Brown, and her son, Tom Sander Gill, and so next to her husband and daughters in plot K27. The original parish record has not always been

transcribed correctly but the plot code, K28, confirms that it is Ann Gill who was 67 years old.

None of the plots K27/8, M19/20 nor L81 have headstones or kerbstones. K27 and K28 are roughly in the position marked below. This is the plot for which John Lister Clay, in his Will, left money for its upkeep, in memory of his friend Tom Sander Gill.



The two brothers-in-law were also buried in St. Matthew's churchyard. John William Pulman died on 10<sup>th</sup> February 1923 aged 54 years. At the time he was probably still at 21, Ripley Street where he had lived all his married life. He was buried with his wife Sarah Martha in plot L81 on 14<sup>th</sup> February 1923.

Albert Booth of 11, Elm Terrace, Bradford Road, Brighouse was a widower for over thirty years. He was 74 years old when he died on 29<sup>th</sup> April 1949. M19 was recorded as the plot in which he was buried on 3<sup>rd</sup> May 1949 and so he too was with his wife, Isabella, and their young children.
